The Board of Directors currently has four official members: Scott Houston, Geneo Young, Dave Maurer and Meghan Newsome. Justin Rametta was on the board of directors, but relinquished his seat on the board when taking over for Karen Sawyer as manager of the company. Karen and Justin made this switch in October 2023. Bob Martin has been sitting in as interim board member since December and will be formally put to vote at the upcoming meeting in March. You may vote for Bob on the proxy on the reverse side. Also, a space is provided to write in other potential candidates if you have one.

As you are likely aware by now there has been a lot going on in our company in the past year. We are in the middle of a major infrastructure improvement project replacing all of our main distribution lines. This work is expected to resume in the spring. We have recently acquired a new company logo (pictured above). This year we plan to have new cellular transponders installed on every service meter to provide leak detection notifications and allow for monthly meter reads and billing to be done online. We are in the process of implementing new digital billing software that will provide a customer portal for everyone to have access to their usage data and pay your monthly bill online using credit/debit cards or setup auto pay with your bank like the rest of your utility services.

Most importantly we would like to announce the switch from an analog, all paper based company, to a more current paperless version. This includes making the switch to receiving all communication and billing in the future via email. Unfortunately we do not currently have an email address on file for every property in the neighborhood. We kindly request that you send an email to contact@highvalleywater.com to have your preferred email address added to your account. If you have been receiving email communication from us in the past, there is no need to send one in unless you'd prefer we use a different address for communication and billing going forward.
